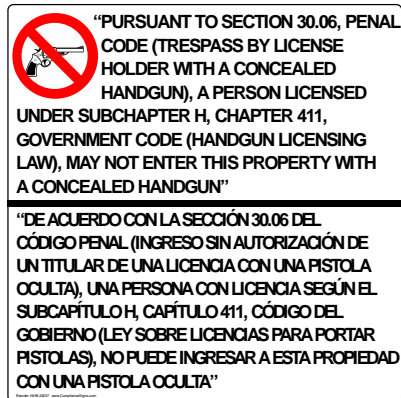


GUIDE TO TEXAS 30.06 and 30.07 GUN SIGNS

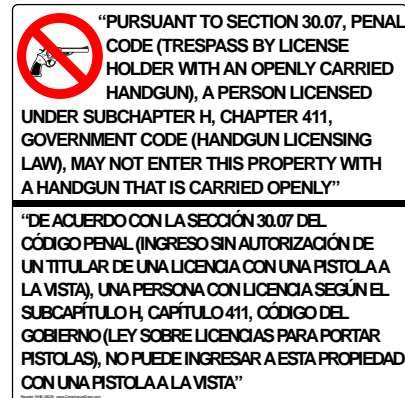
This document is meant to serve as a resource to answer some of the most asked questions regarding these signs.

OUR SIGNS

The Texas 30.06 and 30.07 signs that we offer on our website meet the requirements as outlined by the state of Texas to be compliant.

A private business or property owner may voluntarily create a "weapons free" zone by posting a 30.06 and 30.07 sign on their premises even though CCW would normally be allowed.

- **Design of Concealed Weapons Signs:** Information excerpt from Texas CRB.
- By state law, the owner of a private property may forbid **Concealed Carry weapons** in or on their premises by posting a sign stating: "PURSUANT TO SECTION 30.06, PENAL CODE (TRESPASS BY LICENSE HOLDER WITH A CONCEALED HANDGUN), A PERSON LICENSED UNDER SUBCHAPTER H, CHAPTER 411, GOVERNMENT CODE (HANDGUN LICENSING LAW), MAY NOT ENTER THIS PROPERTY WITH A CONCEALED HANDGUN."
- Property owners can also forbid **Openly Carried** weapons by posting a sign stating: "PURSUANT TO SECTION 30.07, PENAL CODE (TRESPASS BY LICENSE HOLDER WITH AN OPENLY CARRIED HANDGUN), A PERSON LICENSED UNDER SUBCHAPTER H, CHAPTER 411, GOVERNMENT CODE (HANDGUN LICENSING LAW), MAY NOT ENTER THIS PROPERTY WITH A HANDGUN THAT IS CARRIED OPENLY."
- The sign text must be in block letters at least one inch in height with contrasting color and be presented in both English and Spanish in a manner that is clearly visible to the public.
- **Property owners should post BOTH signs if they want their property perceived to be completely gun free.**

Below are the regulations shown on the link above:

Effective 1/1/2016, a sign posted under §30.06, Texas Penal Code, must do the following:

- ♦ Include the following text in English and in Spanish:
- ♦ Pursuant to Section 30.06, Penal Code (trespass by license holder with a concealed handgun), a person licensed under Subchapter H, Chapter 411, Government Code (handgun licensing law), may not enter this property with a concealed handgun”
- ♦ Appear in contrasting colors with block letters at least one inch in height; and
- ♦ Be displayed in a conspicuous manner clearly visible to the public.

- ♦ Include the following text in English and in Spanish: “Pursuant to Section 30.07, Penal Code (trespass by license holder with an openly carried handgun), a person licensed under Subchapter H, Chapter 411, Government Code (handgun licensing law), may not enter this property with a handgun that is carried openly.”
- ♦ Appear in contrasting colors with block letters at least one inch in height; and
- ♦ Be displayed in a conspicuous manner clearly visible to the public at each entrance to the property.

CUSTOM SIGNS

Any alterations made to the signs offered on our website make them non-returnable and risk not meeting compliance.

Alterations consist of, but are not limited to:

- ***Combining the 30.06 and 30.07 signs into one abbreviated statement***
